

# Lilydale Heights College Student Dress Code

## PURPOSE

The purpose of the Student Dress Code is to outline Lilydale Heights College's requirements for student dress and appearance and to provide information about uniform purchase and support, dress code implementation and exemption processes.

This dress code has been developed by Lilydale Heights College's School Council in close consultation with our school community to ensure that it respects the rights of individual students whilst reflecting the values and interests of our community.

The Student Dress Code aims to:

- foster a sense of community and belonging and encourages students to develop pride in their appearance.
- support Lilydale Heights College's commitment to ensuring that our students feel equal and are dressed safely and appropriately for school activities.
- reduce student competition on the basis of clothing and accessories.
- promote cohesion and an orderly learning environment.
- ensure students' appearance reflects the expectations of their school community.
- enhance the profile and identity of the school and its students within the wider community.
- prepare students for the expectations of workplaces.
- adhere to OHS Requirements.

## SCOPE

Students are expected to comply with this Student Dress Code while traveling to and from school, during school hours and when attending school activities.

## UNIFORM AND APPEARANCE

The full list of Lilydale Heights College's compulsory school uniform items are available at Appendix A to this policy.

### **General appearance**

While at school, travelling to or from school or participating in school activities, students must comply with the following:

- Uniforms must be clean and in good repair.
- Additional layers of clothing may be worn underneath the uniform for added warmth, provided these undergarments are either plain white or completely hidden.
- Hair colouring should be within the range of natural colouring. Extreme hair colouring and styles are not permitted.
- Ear piercings are to be small (sleepers or studs).
- Body or facial piercings must be clear or removed. Covering facial piercings with tape is not acceptable.
- Minimal jewellery is to be worn.
- Minimal make up is to be worn.
- Tattoos for children under the age of 18 are illegal in the state of Victoria. Students over the age of 18 must have their tattoos covered.

- Students are permitted to change into runners at school when engaged in the following activities:
  - Walking to and from school
  - To play sport at recess and lunchtime on the oval, basketball courts, gym or stadium.
 Students must change into their school shoes when they have finished the above activities. Students are expected to wear their black leather polishable school shoes at all other times of the school day (excluding when they are wearing their PE uniform for classes).
- Year 7 & 8 students only may wear their PE uniform for the whole day on days they have PE and Sport.
- Students are not permitted to substitute PE uniform items with their Daily Uniform.

### **Health and safety**

Jewellery, nails, hair accessories and similar items that interfere with students' ability to engage with school activities safely and fully are not permitted.

Students with longer hair may be asked to tie their hair back for safety purposes in some classes. When asked to do so, students are expected to comply. If students do not have their hair tied back, they may be excluded from the practical activity for their own safety.

The College Council and Administration reserve the right to request the removal of any clothing or jewellery that is considered an Occupational Health and Safety risk.

School uniform hats may be worn outside, by parent or student choice. Hats are not to be worn inside.

Students are permitted to wear sunglasses during outdoor activities. Sunglasses should be close-fitting, wrap-around that meet the Australian Standards 1067 and cover as much of the eye area as possible.

Students are to wear black, leather polishable school shoes to provide additional protection to their feet. This safety measure is important for practical based classes and activities which include, but is not limited to, Science, Product Design, Systems, Food Studies and Art.

### **PURCHASE OF UNIFORMS**

Uniform items can be purchased from PSW School Uniforms.

The School Council has considered affordability in the development of this dress code. However, if you are facing difficulty meeting uniform costs the [Help with school costs and fees](#) page provides advice on support offered by the Victorian Government. If your child is starting prep or year 7 and is eligible to receive support via the [Camps, Sports and Excursions Fund](#), you may be eligible to access the Affordable School Uniform (ASU) program.

Please contact our Leader of Student Engagement and Wellbeing at the College to discuss support that we may be able to provide.

## IMPLEMENTATION

Lilydale Heights College will ensure that this Student Dress Code is communicated to all families and students through our website and ongoing communication via Compass. We will assist students who may be experiencing difficulties complying with this policy where possible.

### **Out of Uniform – with a note**

We understand that from time to time, a student may not be able to wear an item of their uniform for the day due to unforeseen circumstances. In this case, the student should report to their Learning Team office before school. When presented with an explanatory note, the Learning Leader/Student Liaison:

- Will discuss the reason for being out of uniform.
- Will provide the student with the article of school uniform, where possible, to wear for the day.
- Where a replacement uniform cannot be provided, the Learning Leader/Student Liaison will issue an *Out of Uniform* pass to the student with a specific timeline to rectify the situation.

### **Out of uniform – no note provided**

If a student is out of school uniform without an explanatory note or otherwise breaches the Student Dress Code, the following will occur:

- The student will be provided with the article of school uniform, where possible, to wear for the day.
- The student will receive a notified detention.
- Where a replacement uniform cannot be provided, the student will be issued an *Out of Uniform* pass with a specific timeline to rectify the situation.

### **Facial piercings**

If a student breaches the Student Dress Code policy regarding facial piercings, the following will occur:

- The student will be provided with a clear piercing, where possible, to wear for the day.
- The student will receive a notified detention.

Where a student fails to remove their facial piercing, they will be excluded from the yard for recess and lunchtimes.

### **Ongoing breaches of the Student Dress Code policy:**

Where a student continues to breach the Student Dress Code policy, the following will occur:

- Phone call to parent/guardian.
- Meeting with Student Liaison/Learning Leader/Assistant Principal, parent and student.
- Withdrawal from the yard and/or other school approved activities.
- Exclusion from class due to failing to comply with clear and reasonable instructions from a staff member.

The school will continue to work with the student and family to support compliance.

## EXEMPTIONS TO STUDENT DRESS CODE

We acknowledge that there might be instances where the enforcement of this dress code could impact students differently.

Students and their parents or carers may apply in writing to the Principal for an exemption to this Student Dress Code if:

- an aspect of this code prevents the student from complying with a requirement of their religious, ethnic or cultural beliefs or background.
- the student has a particular disability or health condition that requires a departure from the dress code.
- the student or their parents/carers can demonstrate particular financial hardship that prevents them from complying with the dress code.

When the Principal receives a request for an exemption, they will:

- consider the grounds for the exemption request.
- explain the process to the student and/or their parents/carers.
- encourage the student and/or their parents/carers to support their application with evidence.

The Principal or delegate will then try to negotiate a resolution that is acceptable to all parties. If an exemption is not allowed, then written reasons will be provided to the student and/or their parents or carers.

### CONCERNS ABOUT THIS STUDENT DRESS CODE

Lilydale Heights College welcomes feedback from the school community in relation to this Student Dress Code. If you have a concern or complaint about the Student Dress Code, further information about raising a concern or complaint is available in our school's *Parent Complaint Policy*, available via our website.

## APPENDIX A: Lilydale Heights College Uniform

Uniform items as listed are to be purchased from PSW School Uniforms with the exception of shoes. Please note that alternative brands will be considered unacceptable Lilydale Heights College Uniform.

Daily Uniform	Daily uniform for all students	
	<b>Windcheater</b>	Navy blue with LHC logo.
	<b>Polo shirt</b>	White with LHC logo.
	<b>Footwear</b>	Black leather polishable school shoes (boots are not permitted/no logos permitted).
	<b>Cap/hat</b>	Approved LHC hat.
	<b>Scarves/ Gloves</b>	Plain black, white or navy (no patterns).
	<b>Beanies</b>	LHC Beanie only.
	<b>Spray Jacket</b>	Approved LHC design with logo.
	<b>Trousers</b>	Approved school trousers only.
	<b>Shorts</b>	Approved school shorts only.
	<b>Socks</b>	Plain white socks to be worn with shorts & PE uniform/summer dress/winter skirt. Plain black socks to be worn with trousers/tights. No logos.
	<b>Summer Dress</b>	Approved LHC style & fabric (knee length).
	<b>Winter Skirt</b>	Approved LHC style & fabric (knee length).
	<b>Tights</b>	Black – to be worn with winter skirt only. Black socks only to be worn over black tights.

<b>Physical Education &amp; Sport</b>	<p><i>To be worn for all sporting events and PE classes.</i></p> <p><i>Year 7&amp; 8 students only may wear their PE uniform for the whole day on days they have PE and Sport.</i></p> <p><i>Students are not permitted to substitute PE uniform items with their Daily Uniform.</i></p>

<b>PE/Sports Polo Shirt</b>	Approved by LHC.
<b>Shorts</b>	Approved LHC design with logo.
<b>Tracksuit jacket/pants</b>	Approved LHC design with logo.
<b>Socks</b>	White. No logos.
<b>Sports Shoes</b>	Appropriate sport shoes.

**Accessories**

<b>Hair</b>	Colour & style	Hair colouring should be within the range of natural colouring. Extreme hair colouring and styles are not permitted.
	Headbands/Ribbons	Black, white or navy.
<b>Piercings</b>	Ear piercings	Ear piercings are to be small (sleepers or studs).
	Facial piercings	Body or facial piercings must be clear or removed. Covering facial piercings with tape is not acceptable.
<b>Jewellery</b>		Minimal jewellery is to be worn and may be required to be removed for safety reasons.
<b>Make up</b>		Minimal make up is to be worn.

**Designated out-of-uniform days**

Dress for designated 'out-of-uniform' days (including excursions where relevant) should be appropriate to the activity, to the College Dress Code and context.

- All casual dress items must be neat, tidy and in good repair.
- All casual dress items must be modest, respectful and inclusive (e.g. no disrespectful slogans).
- Clothing items must be suitable to wear in all subjects and align with occupational health and safety standards (e.g. closed toe shoes, no high heels etc.)
- Jewellery: The Student Dress Code policy for jewellery remains in place for out-of-uniform days (i.e. Ear piercings are to be small (sleepers or studs). Body or facial piercings must be clear or removed. Covering facial piercings with tape is not acceptable.
- Make up may be worn discreetly and should not be noticeable.
- The Principal reserves the right to decide on the appropriateness of the wearing of these items.

## PLEASE NOTE -

**YEAR 7 AND 8:** Sports uniform is to be worn **only** on days that you have sport timetabled **or** for sports event days such as athletics and swimming carnival.

**YEAR 9-12:** Students bring their sport uniform to school and change into their uniform **only for the scheduled sport or PE class** before changing back into their regular uniform. Sports uniform to be worn on sports event days such as athletics and swimming carnival.
